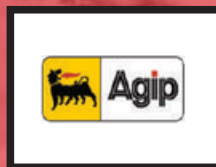
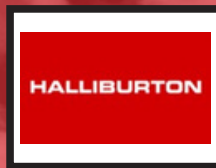
Nigerian Content
